## AN OPEN LETTER TO THE JEWISH PEOPLE

**My Precious Nation,**

**I care about you. I pray for you. I cry over my Tehillim for you. I lay in bed shaking with worry for you.**

**To tell you the truth, I am using my Yom Kippur machzor on Shabbosim because those tefillos seem necessary at this time.**

**Many of you are making the mistake of your lives. If you didn't realize it before, it's not your fault. Most people didn't. But now you must, must wake up. Most of us are being "socially safe" by going along with the majority and not thinking critically, but in this case, political correctness and "going with the flow" can kill. Even if the ideas I am about to share will disrupt your life and cause you anxiety, you are much better off finding out the truth now, when you can still act on it, rather than later.**

**Will you give me a bit of your time so I can explain? Not for my sake, but for yours, and for our whole nation, and for all of humanity.**

**There's an agenda. Something is wrong in the world. If we pretend everything is okay and normal, it will only get more dangerous. Here is how I know this:**

**The government of the United States, as well as those of many other countries, has made clear its plan to inject the corona shot into every citizen, regardless of any particular individual's desire for it, risk factors, age, or prior immunity. This policy goes against sound science, and in fact it is a proof that their vaccination program is driven by profit and political considerations rather than health and safety. (It should be noted that Pfizer and Moderna are set to bring in a combined \$93 billion in 2022 in vaccine sales.) When we look at other countries who are ahead of the United States in their enforcement of the agenda, where people cannot buy food or leave their homes without a vaccine card, we can get a glimpse at where we are headed. You may very well already be vaccinated, but that should be your choice, not the government's choice. You may not want the next booster they demand of you to get, especially if you didn't feel well after the last. But if you allow them to gain control over your medical decisions, you will not regain your autonomy. History shows us that very bad things always happen when the government gains absolute power.**

**How do we know that I am not blowing this all out of proportion?**

**There are in fact many clear proofs that the entire government covid response, including the vaccine mandates, are not being carried out with the benefit of our citizens in mind. Among them:**

**1) The extremely durable immunity conferred by natural infection, and the protection it offers against future strains as well, make the covid-recovered a highly effective buffer to the virus for those around them. Policymakers should welcome these people into the workplace with no restrictions, for their immunity and insurance against transmission is much higher than that of a vaccinated person. In fact, eighty-one research studies confirm that natural covid immunity is equal or superior to vaccine immunity. Yet the opposite is happening, and people with natural immunity are being coerced to vaccinate even though they were excluded from the vaccine trials, and there is a much greater risk of harm to them, according to studies which have found the covid-recovered to have vaccine complications at an increased rate. This coercion is also despite evidence that the vaccine will ruin their strong natural immunity (according to a Red Cross briefing in May stating that recovered patients who subsequently vaccinated could no longer donate plasma), and that there is no benefit to them or to society from their being injected. It is extremely concerning that the shot is being pushed on and mandated for individuals with natural immunity.**

**2) The decades-old, proven safe antiviral medications that can save the majority of covid patients if used early and properly are being suppressed, banned, and vilified by the government and media in a coordinated campaign to make it appear that the shot is the only way out of the pandemic. This suppression of effective treatment at all levels has come at a cost of hundreds of thousands of lives in the United States alone. 3) The one and only drug approved by Fauci as a corona treatment, Remdesivir, turns out to be not only completely ineffective, but so deadly that it was pulled from use in Ebola trials because it was more deadly than Ebola itself, with more than 50% of patients on Remdesivir dying. It causes kidney and liver failure, and water on the lungs. However, hospitals are paid a 20% bonus on the patient's entire bill if they prescribe Remdesivir. 4) The censorship and suppression of the free exchange of information has reached an unprecedented level in the United States. If you look carefully, you will be able to discern a meticulously orchestrated campaign between social media companies, news media, medical organizations, and government, to all be on the same page and to smother and cancel any opposing opinions. The cartel also includes all the big corporations and the pharmaceutical companies. (When you discover that almost every company in the world is owned by the same two parent companies, it becomes clear how news media, pharma, and more coordinate for their common interest. <https://www.lewrockwell.com/2021/04/bill-sardi/who-runs-the-world-blackrock-and-vanguard/>) This cruel "cancel culture" and prohibition of free speech causes most of the doctors who have done their own research and discovered the dangers of the shot, or even are observing their own patients being injured, to be afraid to speak out, for fear of being targeted. 5) Government regulatory agencies such as the CDC and FDA, who are charged with monitoring adverse effects of drugs and treatments to determine safety, are failing to do their jobs, as they continue to ignore the ever-rising death count from the covid shots. Currently the CDC's own adverse events reporting site (VAERS) lists over 19,000 deaths, with internal whistleblowers testifying that the true number is many times higher, while the reporting site of the European Union (Eudravigilance) lists over 31,000 deaths and over two and a half million injuries following the shots. These deaths include dozens of very young and healthy people, some only 13 years old, who have died within a few days, or even a few hours, of the covid injection. See <https://thecovidblog.com/>. For comparison, any new drug or shot that had a dozen or two reported deaths was immediately pulled off the market in the past in the United States. Instead of the transparency one would expect, the agencies seem to be doing their best to hide the truth from the public. 6) The president announced the purchase of enough covid shots for all children aged 5-11 in the United States, indicating his intention to inject every child in the country (even before the sham FDA and CDC meetings), despite no conclusive evidence that *any* healthy child has ever died of the disease. See this study from Germany which could not even find *one* covid mortality of a healthy child in this age bracket. <https://www.medrxiv.org/content/10.1101/2021.11.30.21267048v1.full.pdf> This, while the incidence of myocarditis in young people rose to 19 times the expected rate after the rollout of the shots for that age group. In fact, 1 in 318 young people who get the injection will develop myocarditis. Myocarditis is not a mild disease, and those who survive are left with permanent heart damage, with a 5-year mortality rate of 50%. In addition, at least 54 children between the ages of 12 and 19 have already died from the shots, *in addition to the younger kids who died and have been severely injured in the trials and since the EAU*. Next, they're going for approval of the shot for 2 year olds. On top of everything, what is in the vials has been switched, as Pfizer added tromethamine, a heart attack drug, as a preservative, and zero trials were done on the new formulation, not even on animals. They KNOW the shot will kill kids. 7) Studies comparing many different areas in the United States, as well as other countries, with high vaccination rates versus those with low vaccination rates show absolutely no decrease in illness correlated with higher vaccination rates. To the contrary, there is a correlation between high vaccination and an *increase* in covid cases. (See European Journal of Epidemiology, September 30 '21 "Increases in COVID-19 are unrelated to levels of vaccination across 68 countries and 2,947 counties in the United States.") Thus, there is zero justification for the vaccine mandates, yet those in power continue pressing full force ahead.

We are forced to reach the inescapable conclusion that the policymakers in our government do not seek our best interests at this time.

The propaganda grows ever more shrill, policies are formed that are designed to divide rather than unify, and the government mandates become ever more coercive and choking, as those in power seek with every means at their disposal to force everyone to "vaccinate" – even while it becomes clearer each day that the "vaccines" do not offer the protection promised, and do not guard against transmission. In fact, looking at Israel, which is a few months ahead of us in their campaign, and saw a terrible "fourth wave" of illness and death after the rollout of the "booster shot" (aside from all the other mysterious sudden deaths and strange illnesses being experienced there since the Pfizer campaign began, *Rachmana litzlan*), it is clear that these vaccines do *not* lower the death rate, and actually make the situation much worse.

Many are unaware that the California governor has already declared a vaccine mandate for all schoolchildren in the state, pending FDA approval, and the New York City mayor elect has expressed his intention to enforce citywide corona vaccination of all NYC schoolchildren as well. The impact that this will have on our communities is huge.

It is very painful to us that too many well-intentioned people, including those in positions of authority and leadership, are completely unaware of the great danger that we are all in. Hundreds in our own communities have suffered the tragic results of the shots, whether sudden death, strokes, heart attacks, myocarditis, pericarditis, pleural effusion, blood clots, Guillain-Barre Syndrome, cessation of menstrual cycles among young women, unending menstrual bleeding for months, miscarriage, stillbirth, birth defects, blindness, seizures, severe depression, severe digestive disorders, severe weakness and fatigue, disabling pain, and more, and yet in a separate but parallel universe, authority figures continue to recommend it, as a plague of blindness covers the eyes of so many and the media and establishment continue to claim safety. Most medical professionals and leaders have not done their own intensive research on this topic, but simply rely on others whom they trust, as usual, failing to realize that we are in an unprecedented time in history.

Even worse, there is a concerted effort being made in Eretz Yisrael to trick and manipulate Gedolim into promoting or seeming to promote the shots, while hiding the true data from them (but claiming to have presented both sides.)

**A CHURBAN OF KLAL YISRAEL CARRIED OUT BY OUR OWN PEOPLE, BLINDED AND MOTIVATED BY GOVERNMENT MONEY- WHAT COULD BE WORSE?**

While popular news outlets falsely claim that Rav Chaim, Shlita, has said that 5-11-year-old kids should get "vaccinated" for corona, we know it's impossible that Rav Chaim was truly presented with all the data and actually gave a psak because his own daughter testified that Rav Chaim no longer recognizes her. He is extremely weak, is not himself, and can barely say a word, according to his own family members. Additionally, we have a recording from last December, when Rav Chaim was presented with the FDA's own list of 22 possible deadly side effects of the shot, and he said NOT TO TAKE IT. It is halachically impossible that Rav Chaim said kids should be injected, because kids aren't dying in our communities from corona, so what would be the heter to inject them with a product that many doctors are warning can cause death, and is causing death? If this question was truly and properly presented to Rav Chaim as they claim, let us see the detailed video of the dangers being explained to him as well, together with the fact of zero risk of death from the virus to healthy children, together with the effective available treatments for the virus. Let us see an explanation of why we would not follow the Shulchan Aruch, Orach Chaim 618/4 that tells us that we follow even 2 expert doctors who are concerned about a danger against 100 doctors who say no, there is no problem.

This is not a true directive of Rav Chaim. It cannot be true. Let us see a detailed psak in writing explaining the Halachic reasoning.

It should be noted that there are *two* versions of the video, both of which I have. In the original, when a bracha is requested, the family member had to make the request loudly three times. There is no reason to believe that Rav Chaim heard the previous, critical questions that were asked just once, rather than being prompted by papers that were held in front of him. In fact, I received information that the papers that were being held in front of Rav Chaim had AN ENTIRELY DIFFERENT SET OF QUESTIONS than the ones the family member was asking him on video (which Rav Chaim obviously did not even hear).

The video released by the Misrad Habriut has the repeated request for the bracha, which testifies to the difficulty hearing and casts grave doubt on the veracity of the preceding questions and answers, smoothly edited out.

**SOMETHING IS WRONG HERE.** Pfizer is earning BILLIONS from the shots. Clearly there is an Israeli governmental financial agenda resulting in a tremendous distortion of the truth, and the respect that Jews have for Rav Chaim's word is being abused by those in power to influence the religious community for their own purposes.

Back in the summer, when the propaganda about 12-year-olds came out, my friend spoke to someone very close to Rav Chaim, who testified that a letter proclaiming kids should get the shot was placed in front of Rav Chaim and he said NOTHING - and then the proclamation was issued in his name!

Read this message we received recently: "Hi. I saw reported this morning that Rav Chaim Kanievsky said to vaccinate the 5 year old + children and I felt compelled to write to you to inform you that I have been very close to the Kanievsky home for many years and have been mainly close to Rav Chaim and there's no way that Rav Chaim was maskim to vaccinate the children. I have also spoken to other people close to Rav Chaim and they agree, two of whom had personally asked Rav Chaim if they should vaccinate their children and he answered with an unequivocal NO. There's a hidden agenda going on with one of Rav Chaim's family members who keeps saying things in Rav Chaim's name. This is extremely dangerous as Torah Yiddin obviously take Rav Chaim's word as halacha. My message is be wary of information that you get that seems legitimate but may very well not be."

Indeed, anyone who knows Rav Chaim's style from before and thinks carefully will realize that this directive to vaccinate kids goes exactly counter to everything Rav Chaim always stood for. Rav Chaim would always say to focus on the ruchniyus – to increase bitachon, davening, learning, and mitzvos. He would instruct people to ignore doctors' dire predictions and *not* do the extra medical interventions the doctors desired to perform.

In any case, this whole story is totally wrong in every way because **THIS IS NOT HOW HALACHA IS DECIDED.** Not by video. Not by Ruach Hakodesh. Not by a blanket directive to Klal Yisrael. Not by a 30-second Q and A for a life-and-death decision on a new, experimental medical intervention. Our Mesora dictates that you go to your Rav and present your question. The more danger involved, the more complicated the Halachic question is, and the more time, research, and details will be needed to present, investigate, and decide. A teshuva is then issued in writing explaining the sources and thought process used to arrive at the Halachic decision. Other Rabbonim may then agree or disagree. If the topic is controversial, they will argue it out vociferously and a debate will ensue with opinions flying back and forth – backed up by Halachic proofs. This is how Halacha has always worked in Klal Yisrael. What has changed?

If this video "psak" concerned the use of a brand new type of electronic appliance on Shabbos and gave a shocking heter to use it, against all logic, what frum person would allow themselves to follow the video directive? People would be up in arms about the fraud and everyone would consult with their own Rav, who would do a thorough independent

investigation of the technology and the resulting Halacha. Why do our children's very lives merit less consideration? What a bizayon HaTorah, as those who seek to profit from the shot use the image of a Gadol Hador to prop up their lethal agenda.

Contrast the tragic sham above, obviously being carried out for profit motives and with a complete disregard for the safety of Klal Yisrael, with the Beis Din that convened in Brooklyn and carefully heard eight hours of expert testimony and recorded and *publicized* the entire day's events. The Rabbonim came out with a courageous psak saying that the shots are absolutely forbidden for children and all people of childbearing age and issued a strong warning about the dangers for everyone else. The psak can be viewed on macabim.org. On that site, you can also see videos of Dayan Yoel M. Friedman and Rav Shlomo A. Pollak, who have done independent research, clearly warning people of all ages NOT to get the shot EVEN if it means giving up their jobs, and coming out strongly against institutions mandating it.

Additionally, Rav Vosner in Eretz Yisrael, the grandson of the Shevet Halevi, heard dozens of hours of testimony with his Beis Din, and ruled that not only is the shot absolutely forbidden for children, but EVERYONE WHO CAN PROTEST MUST DO SO WITH ALL THEIR MIGHT. **I will now prove to you that the covid shot is A) dangerous, B) ineffective, and C) unnecessary.**

### **A) THE SHOT IS DANGEROUS – Why?**

1) The **POSSIBILITY OF SEVERE ALLERGIC REACTION, ANAPHYLAXIS, AND IMMEDIATE DEATH**, due to the PEG (polyethylene glycol) in the LIPID NANOPARTICLE in the injection.

2) The **SPIKE PROTEIN** that the injection induces the body to produce causes heart damage, inflames lung tissue, and causes vascular issues such as stroke and blood clots. Research shows that it is the *spike protein itself that is the problem in corona – and now we are programming people's bodies to make it in THE TRILLIONS*. 3) **MICROCLOTS: IT IS NOW CONFIRMED THAT A MAJORITY OF VACCINATED PEOPLE HAVE TINY BLOOD CLOTS throughout their bodies**. The clots cause slow, silent damage to blood vessels and organs, which will lead to heart failure and death, G-d forbid, within a few years, according to Dr. Charles Hoffe. The clots are too small to show up on scans, but are seen on D-dimer blood tests and on blood smears viewed under a microscope. 4) **RUINING OUR IMMUNE SYSTEM:** According to Geert Vanden Bossche, top vaccine developer, the massive quantity of highly specific antibodies, which the body is induced by the injection to make against a single strain of coronavirus, will crowd out and dominate our natural antibodies that are NOT specific and can fight ANY pathogens. *Thus, we are immobilizing our immune system's response to other strains of the virus, and to other viruses and diseases.*

5) **HARM TO FERTILITY AND PREGNANCY:** Severe harm is being seen to pregnancy. One possible explanation is the following: The antibodies that the body produces against the spike protein may also attack the body's reproductive cells (egg, sperm, and placenta) in a process called molecular mimicry, since the two proteins are extremely similar. *There are crucial differences between the antibodies from natural infection and the injection-induced antibodies, ONE of which is the fact that the natural ones do not remain in circulation for long, but rather the cells producing them go into hibernation in the bone marrow, while the injection-induced ones ARE circulating long-term, in response to the spike proteins that the body's cells keep on churning out.*

6) **THE LIPID NANOPARTICLES, WHICH HAVE BEEN PROVEN TO CONTAIN HIGHLY TOXIC AND HIGHLY CARCINOGENIC SUBSTANCES**, have been found to settle in high concentrations in the ovaries, testes, spleen, and bone marrow, raising grave concerns about reproductive damage, leukemia, and other cancers. 8) **ANY CORONAVIRUS INJECTION CARRIES THE HIGH, LONG-TERM RISK OF ANTIBODY-DEPENDANT ENHANCEMENT (ADE)**, which causes the immune system to overreact when faced with the virus it was immunized for, and can lead to death. There are some viruses, including dengue, RSV, and coronaviruses, for which vaccination is *not* the solution because it results in *enhanced* disease, *not* prevention of disease. Animal trials for previous coronavirus vaccines never made it to market for this exact reason, because the animals in the trials died *in the long term*. It took up to three years for ADE to affect them. With the current injections, they *skipped most animal safety trials*. There is no way we can be sure that this vaccine will *not* cause ADE in the long term. Indeed, **there is no such proof**, as there were no adequate animal safety trials on this vaccine, and not enough time has passed in the human trials that are still ongoing on the world population. Actually, some scientists believe that the spike in disease rate soon after vaccination, and the increased death rate among the vaccinated who contract covid, is a form of ADE.

**Are these warnings actually coming true? Tragically, the answer is YES. I have compiled a list of some of the personal stories in our communities that I know of closely.** These are REAL PEOPLE who died or are suffering terribly. **These are but a tiny fraction of a fraction of the millions of victims of this shot worldwide.**

1) A woman wrote to me: “So sad to say that my nephew’s wife in the UK had the shot then found out she was pregnant. 5 weeks later she started miscarrying, with terrible pain, and went to the hospital, bleeding heavily. Hooked up to a sonogram, they all watched while the baby – with a live heartbeat – bled out of her body. Just bled out. It’s horrific. And to watch it happening??”

2) My own cousin’s daughter-in-law lost her baby immediately after her shot, which she was forced to take for her job.

3) My friend’s friend’s daughter, who vaccinated during pregnancy, had a stillborn baby. We have heard COUNTLESS stories OF MISCARRIAGE AND STILLBIRTH AFTER THE VACCINE.

4) In NY, multiple obstetricians, a Chevrah Kadisha, and a chapel all have reported a horrifyingly exponential, unprecedented increase in stillbirths at this time.

5) One of my Rabbis warned a yeshiva student not to vaccinate, but he did so, and subsequently passed away in his sleep in Israel shortly afterwards. My Rabbi told me to publicize the story to raise awareness.

6) A girl in the community wanted to go to Israel and took the shot, and became paralyzed as a result. This was reported to me by someone I’m in contact with, who has a connection to the family. The family refused to go public.

7) A man I know got vaccinated at his doctor’s insistence. He developed pericarditis and water around his heart and literally almost died. He needed emergency surgery to remove the water around his heart, was in the hospital for a while, and was subsequently re-hospitalized. He’s still not back to himself after months and realizes that this may be a lifelong issue.

8) I spoke with a woman who developed Guillain-Barre Syndrome right after her Covid shot. She has to go for regular therapy and is in pain every day.

9) A woman I spoke to became extremely ill after her Covid injection, with terrible headaches, chest pain, and then losing the feeling in one leg. She was hospitalized with a host of problems. Thank G-d, after she was told to make a recording to publicize as a warning to others, as a merit for herself, she got better (with the help of intense work).

10) A lady that I’m in contact with had her husband lose THREE friends after Covid vaccination, and she knows TWO women who vaccinated before or during pregnancy who were told bad news about their babies. One gave birth already, and her baby passed away immediately.

11) Another woman that I know became severely disabled immediately after her shot. It's been many months already and she can't exert herself for more than 10 minutes without needing to rest. She had to give up her business and can't run her home or care for her kids.

12) A man told me the story of his grandmother, who didn't have heart problems, but had a right aortic heart attack very soon after her shot, had a stent placed, and still wasn't feeling better as time went on. We've unfortunately heard many stories of heart attacks, blocked arteries requiring stents, and strokes in previously healthy people soon after the Covid shot.

13) Someone I know told me about a nurse in the hospital where a relative works, who simply collapsed and died in the hallway a few days after her shot. This scene of sudden collapse and death or of not awakening from sleep IN PREVIOUSLY HEALTHY INDIVIDUALS is now happening frequently in Israel, may G-d have mercy. (I have many headlines from Israeli religious papers with these stories. But most people don't seem to connect the dots. When you think of a shot as safe you don't begin to consider it as a possible cause of death.)

14) The same person also told me about a young woman she knew who died of an aneurysm within days of her Covid vaccine.

15) A woman I met told me about BOTH her parents who started having terrible problems after the injection. Her father developed severe clinical depression and became suicidal. Nothing helped, and eventually he had to go for shock therapy. His vision and his gait have also deteriorated. Previously he was a healthy man. Her mother developed severe digestive problems, which are still going on many months later. ALL of these health issues are not uncommon after the shot and I've heard similar stories before, including suicide, psychosis, and lots and lots of digestive problems, such as terrible stomach pain, inability to eat almost anything, inability to digest or to swallow, and life threatening diarrhea.

16) I have received testimony about **TWO** women who each didn't stop bleeding for **5 months** after their shots, one of whose cycles are now so short that she cannot conceive, and another woman who bled for 3 months. There are many, many other stories of ongoing bleeding. I recently received a story of a young mother who is still staining now, **SIX MONTHS** after her shot! Other people I know are aware of a seminary where almost every girl vaccinated. The overwhelming majority of girls subsequently either lost their periods or had problems with their periods. Remember, it is known WHICH SEMINARY THIS IS. It's REAL! Will these girls ever have kids??

17) A lady whose husband and son got the shot (not even her!) bled for months. Countless women report terrible bleeding and spotting problems, and miscarriages, as well, from being around their husband, in laws, or others who were vaccinated.

18) A lady I know reported that her friend's son became blind after his Covid shot. Again, this is not a one-time event. If you search VAERS you'll see many such cases. There are stories of deafness as well, one of which my son knows personally.

19) Older, weaker, and more frail people, and those with preexisting conditions, seem even more likely to die from the shot than the regular population. A lady I'm in contact with in Israel told me that in her relative's nursing home, all 14 people who received the shot died within 2 days. Along similar lines, a Rabbi told me of his talk with a nursing home administrator, who told him about a certain percentage of the residents who die soon after the corona vaccine. Remember, the shot was not tested on frail nursing home residents in the trials.

20) I spoke with a woman whose uncle, Rabbi Pinye Korf, was forced to take the shot in the rehab center where he was recuperating after having had the virus. Even though one arm became paralyzed after the first shot, they insisted on giving him the second one, after which his whole body became paralyzed and he passed away. She recorded a testimony about the tragic incident.

21) My friend's brother knows of a mother of a large religious family in England who passed away of a heart attack within 2 days after her Covid injection, leaving many orphans at home.

22) A woman I spoke with told me the tragic story of her husband's very good friend, who did not wake up on Shabbos morning soon after his Covid vaccination.

23) A man I know spent a long time speaking personally with someone who was visiting from Israel, trying to talk him out of the corona shot he was planning to get while here in the US. He was ultimately unsuccessful in dissuading him, **and the visitor received the shot** here and subsequently collapsed and tragically passed away of a heart attack on the street in Brooklyn, while talking to his wife on the phone.

24) My friend knows a previously healthy man in his 40's who got both shots and subsequently started having heart issues. He passed away shortly thereafter.

25) Someone told me of a lady she knows of who had a cardiac arrest a few hours after her Covid injection. While they managed to get her back, she suffers from ongoing heart issues.

26) Multiple family members of the patient have related to me the story of a man in Monroe who became extremely sick after the second shot, to the point that a hospital room had to be set up for him in his home. Eventually he was hospitalized and became so critical that the special prayers at the time of death were said with him – on two occasions. Miraculously, he survived. The man made it very clear that he did not “catch corona,” as rumor had it, but that his illness was a direct result of his Covid vaccine.

27) A man I know told me of his great aunt, who passed away in her sleep after the Covid injection.

28) A woman I know knew a healthy and active elderly man who resided in a senior living place and was forced by the facility to get the shot in order to be allowed to venture off-grounds. He wanted to be able to go to Torah classes so he got injected. Sadly, he never got to go to any classes because he passed away of a heart attack the next day.

29) I spoke to a man who works in a small business. Out of 9 coworkers who got vaccinated, 1 passed away and 1 suffered severe adverse effects.

30) A friend’s father became disabled after his Covid shot and many months later, lives in a special hospital room set up in his home. He has also undergone surgery for a heart condition he developed post-injection.

31) A woman I’m in contact with told me firsthand what happened where she lives: In a small Jewish community of only 400 families, two men, one of them young, who were injected with the Covid shots passed away within weeks.

32) Just after the rollout of the shots to young kids, a 9-year-old boy in the NY area suffered a severe seizure immediately upon receiving the Covid injection and was taken away by ambulance, unresponsive.

33) I saw the terrible footage of a 13-year-old girl who was found lifeless in the street in Israel several weeks ago, having received the Covid injection the day before.

34) I spoke to a longtime Hatzalah member in Israel, who testified to the following: Two men he knows had severe strokes right after their injection – one was in the ICU for two weeks, the other a young person in his 50’s who became paralyzed. Two other men he knows started having severe stomach pains after the shot, described as feeling like knives cutting their stomachs, to the point of being unable to eat and having to hold a pillow over their mouths to keep from screaming. One of these men also had chest pains and went to the ER. The doctor, whom the man was acquainted with, told him, “We are not allowed to say that anything is from the injection.” He mentioned that other people have ringing in their ears and migraines since their shots.

35) A Rabbi with diabetes was pressured to get the Covid injection. He felt unwell and began shaking after the first injection, but was still pressed to take the second one. Within two days he was shaking uncontrollably. He was brought to the ER where he passed away from a massive heart attack.

36) A healthy man in Lakewood got the Covid injection and very shortly afterwards started having blood clots and infections. He was hospitalized and things went from bad to worse. His leg was amputated and eventually he passed away. This was confirmed by the family and related to me by someone I know who was involved.

37) A Rosh Yeshiva told us about THREE Rabbis that he personally knows of who were injected and passed away right afterwards.

38) My friend’s high school age daughter in Israel testifies that in her class, among the girls who are vaccinated, someone or another faints or becomes unresponsive once or twice a week. (What are these if not mini-strokes, causing brain damage bit by bit and putting them at risk for major strokes at any time?)

39) One of my Rabbonim just told me of two tragedies: An older woman, the aunt of someone he knows, died in her sleep two weeks after her shot, while a neighborhood man, also a relative of someone the Rav knows, passed away a few weeks ago, two weeks after getting the Johnson and Johnson shot and getting a blood clot.

**Almost every single story here is that of a religious Jew from our communities! The people are all too real. In almost every case, I have the contact information for the family/victim or someone who knows them. And yet, somehow, too many people in our communities still think the shots are safe!**

Why is that? The common denominator in these stories is that even if you heard or read them already, NOBODY spoke of the truth, that these people had gotten the new, experimental vaccine and died/became disabled/lost a baby shortly afterwards! This silence is killing people, may Hashem have mercy!

Strangely, it seems taboo to say publicly that someone died because of the shot. In fact, that's why I mostly haven't written the names of the victims in these stories. Many family members get very upset if it's said that their relative died after Covid vaccination. **The question is why? Is it somehow more private or shameful than any other cause of death, or do they have guilt feelings and prefer to deny the correlation, or are they afraid to speak out?** If it's OK to say that someone died of any other cause, why is talking about this cause forbidden? **Why should we continue marching forward and giving sacrifices blindly?**

**As Jews, we have a responsibility to guard our lives and health, and we have an equal responsibility not to stand by our brother's blood.**

**Therefore, please consider the following, by Dr. Peter McCullough, who is a top world cardio renal specialist, and the most cited doctor in his field:**

### **10 Reasons to Drop Support or Mandates for Investigational COVID-19 Vaccines**

1. COVID-19 vaccination is voluntary research. The COVID-19 public vaccination program operated by the CDC and the FDA is a clinical investigation and under no circumstance can any person receive pressure, coercion, or threat of reprisal on their free choice of participation. Violation of this principle of autonomy by any entity constitutes reckless endangerment with a reasonable expectation of causing personal injury resulting in damages.
2. COVID-19 vaccines do not work well enough. The current COVID-19 vaccines are not sufficiently protective against contracting COVID-19 to support its use beyond the current voluntary participation in the CDC sponsored program. Tens of thousands of SARS-CoV-2 vaccine breakthrough infections resulting in hospitalization or death have been disclosed by the CDC. COVID-19 vaccines have failed to protect Americans from COVID-19 hospitalization and death. CMS data show the majority of seniors > 65 years hospitalized with COVID are VACCINATED!
3. Multiple studies demonstrate all the COVID-19 vaccines have substantially diminished protection after six months and none of the vaccines have demonstrated adequate immunity from the 99% prevalent Delta variant in randomized trials.
4. COVID-19 vaccines have a dangerous mechanism of action. The Pfizer, Moderna, and JNJ vaccines are considered "genetic vaccines" or vaccines produced from gene therapy molecular platforms.<sup>[i]</sup><sup>[ii]</sup> They have a injurious mechanism of action in that they all cause the body to make an uncontrolled quantity of the pathogenic spike protein from the SARS-CoV-2 virus which persists in the human body for over a year. This is unlike all other vaccines where there is a set amount of antigen or live-attenuated virus. This means for the Pfizer, Moderna, and JNJ vaccines it is not predictable among patients who will produce more or less of the spike protein. The spike protein itself has been demonstrated to injure vital organs such as the brain, heart, lungs, as well as damage blood vessels and directly cause blood clots. Additionally, because these vaccines infect cells within these organs, the generation of spike protein within heart and brain cells in particular, causes the body's own immune system to attack these organs.
5. There is a burgeoning number of cases of myocarditis or heart inflammation among individuals below age 50 years.<sup>[iii]</sup> The Centers for Disease Control has held emergency meetings on this issue and the medical community is responding to the crisis and the US FDA has issued a warning on the Pfizer and Moderna vaccines for myocarditis.<sup>[iv]</sup> It is known that myocarditis causes injury to heart muscle cells and may result in permanent heart damage leading to heart failure, arrhythmias, and cardiac death. Because this risk is not predictable and the early reports may represent just the tip of the iceberg, no individual under age 50 under any set of circumstances should feel any obliged to take this risk with the current genetic vaccines particular the Pfizer and Moderna products.
6. The US FDA has given an update on the JNJ vaccine concerning the risk of cerebral venous sinus thrombosis in women ages 18-48 associated with low platelet counts.<sup>[v]</sup> The JNJ has an FDA warning for Guillain-Barre Syndrome. Because these risks are not predictable, no person under any set of circumstances should feel any obliged to take this risk with the JNJ vaccine.
7. COVID-19 vaccines are generating record safety reports. In 1990, the Vaccine Adverse Event Reporting Systems ("VAERS") was established as a national early warning system to detect possible safety problems in U.S. licensed vaccines.<sup>[vi]</sup> VAERS is a passive reporting system, meaning it relies on individuals to voluntarily send in reports of their experiences to CDC and FDA. VAERS is useful in detecting unusual or unexpected patterns of adverse event reporting that might indicate a possible safety problem with a vaccine. The total safety reports in VAERS all vaccines per year up to 2019 was 16,320. There are nearly a million total safety reports in VAERS for COVID Vaccines alone breaking all records for lack of safety.<sup>[vii]</sup>

8. People are dying and being hospitalized in alarming numbers in the days following COVID-19 vaccination. Based on VAERS data through the present time, hospitalizations, urgent visits, and permanent disability are occurring in tens of thousands of vaccine recipients (Pfizer, Moderna, JNJ).

9. There is a reasonable expectation for more harm than benefit for the following groups at all age ranges: COVID-19 recovered, suspected COVID-19 recovered, women of childbearing potential, children, persons with one or more chronic diseases.

10. Any personal choice or protected health information concerning the COVID-19 vaccine and its complications is confidential and anonymous according to federal law, and subject to additional federal fines and penalties for violation of protected health information laws and statutes.

In conclusion, the investigational, genetic COVID-19 vaccines are not safe for general use and cannot be deployed indiscriminately unless proven otherwise. Please cease and desist pressure/harassment/mandates for COVID-19 vaccination.

## Let us delve a bit deeper into what is happening here.

### 1) Were there any third-party, unbiased studies to determine the safety and efficacy of the covid injections?

There are NO third-party, unbiased studies to determine the safety of the Covid-19 vaccines. The pharmaceutical companies ran their trials themselves, without oversight, and reported their findings to the FDA. Clearly, with billions of dollars in profits at stake, there was ample motivation to manipulate both the safety and efficacy data in order to arrive at numbers that would result in product authorization and in enthusiasm and acceptance by the public. No kosher certifying agency would ever be able to give a kosher certification on any product produced under such conditions. There is all the more reason for concern, as Pfizer has repeatedly engaged in fraudulent behavior for financial gain, to the point that they were actually fined \$2,300,000,000 in 2009, the largest healthcare fraud settlement in history. Indeed, there is ample evidence of the manipulation that Pfizer has done of their data to try to make the vaccine appear both effective and safe. If you read the above article from America's Frontline Doctors about the dishonest children's trial protocols that the FDA approved of, you see that something is very wrong here, and the FDA is not doing their job to ensure safety. Neither is this the first time such a travesty is occurring in the FDA. The agency has previously approved drugs and medical products that it knew to be dangerous or untested. These incidents, and the corruption by some top officials at the FDA, were clearly expressed in 2009 letters to President Obama and to Mr. John Podesta, written by whistleblowers at the Department of Health and Human Services, and obtained under the FOIA.

Not only are the trials questionable in themselves, but even based on the trial data they present, the true risk reduction to any individual, called "absolute risk reduction (ARR)," is the only number that matters, and that is less than 2% for any of the shots. The number that the manufacturer has been presenting to the public is the "relative risk reduction," or RRR, which isn't meaningful. **The claim that "VAERS assures safety" is ridiculous for a number of reasons, the most obvious being that the over 19,000 deaths listed there after corona vaccines alone, in less than one year, is more than double the deaths listed for all other vaccines combined in all the years of the existence of the database. Also:**

**A)** By its very design, the database will only detect problems AFTER the vaccine has been given to a large portion of the population. VAERS is no substitute for a proper trial with unbiased third-party oversight before a vaccine hits the market.

**B)** Previous studies have shown that only between 1-10% of adverse reactions get reported to VAERS, as a government-funded Harvard study in 2016 indicated. See page 6: <https://digital.ahrq.gov/sites/default/files/docs/publication/r18hs017045-lazarus-final-report-2011.pdf>. This would mean that 19,000 deaths now reported after the vaccine really indicate a total of at least 190,000 deaths. This would jive with the increased all-cause death rates now being seen, which incidentally were NOT seen in 2020.

**C)** Much of the population does not know about the existence of this database, so they cannot file reports.

**D)** Many people believe that the vaccine is very safe, and thus do not draw any connection between the covid-19 vaccine and subsequent illness or death, so they wouldn't be reporting anything. I know countless stories that bear out this fact, and so does a doctor I discussed this with.

**E)** Many doctors refuse to conclude that an adverse event is connected to the covid-19 vaccine and will not file a report, even if the patient's family suspects a connection.

**F)** Other doctors do not have time to file multiple VAERS reports for all the adverse events they are seeing after covid-19 vaccination. (This was personally told to me by a gastroenterologist about her own practice.)

**G)** Doctors are sometimes finding that the VAERS system will not accept their reports. Dr. Zev Zelenko testifies that he personally knows of twenty instances of patient deaths after the covid-19 vaccine in which a doctor attempted to make a report to VAERS and the report was not accepted.

**H)** Two whistleblowers in the CDC, and one in the CMS, according to Dr. Peter McCullough, have come out saying that the CDC is actually concealing tens of thousands of reports of deaths that they have received. In fact, on July 19, America's Frontline Doctors filed a lawsuit in California against the CDC, based on the sworn testimony of a whistleblower within the government, whose access to the databases allowed her to discover that 45,000 Medicare and Medicaid patients *alone* have died *WITHIN 3 DAYS* of their shots, and the CDC has been hiding this information. **I)** Hospitals are making a concerted effort to NOT report deaths and adverse events post covid injection. Here are **three** examples that I am personally aware of: Deborah Conrad, a hospital PA who came out as a whistleblower and whom I personally spoke with, was fired from her job because of her diligence in reporting to VAERS heart attacks, strokes, deaths, etc., in hospital patients shortly after their covid vaccinations.

Another striking example is a story that someone personally related to my family member. His neighbor's teenage son was hospitalized with myocarditis after the covid shot and remained there for a few weeks. When he was finally discharged, his mother went to their local pharmacy. The pharmacist was very upset at the boy's illness and reported it to VAERS. He got a call from the CDC asking why he was reporting and not the hospital. Upon further investigation, the hospital admitted that they had received orders NOT to report these events.

The third example concerns a nurse who was fired from a hospital for truthfully listing the covid vaccine as the cause of death on 40 death certificates. A man that I know well spoke to this nurse personally.

**Even** with all the above limiting factors, VAERS is still tragically showing over 19,000 dead. (See [www.medalerts.org](http://www.medalerts.org) and chart below.) These are people who died in very close proximity to their receipt of the covid-19 shot, 50% of them within 48 hours. An outside analysis of a sample of the reports by McLachlan et al from London has shown that 86% of the deaths are directly related to the vaccine. While the CDC attempts to downplay the veracity of the VAERS reports, stating, "This site contains unverified reports," in actuality, 83% of the reports were made by healthcare professionals, such as a doctor, nurse, or paramedic who cared for the patient, and believed that their death was related to the covid-19 shot they had recently received.

To put the number of deaths in about one year from the covid-19 injections into perspective, it must be noted that a typical year sees under 200 deaths for ALL vaccines combined, and that the deaths now are double the total of thirty years of death reports for

all other vaccines together. Thus, using the VAERS system to verify the safety of the covid-19 shots actually does not yield a very reassuring outlook at all. We are on track to see, G-d forbid, 20,000 covid-19 vaccine-associated deaths this year on the VAERS system, compared to under 200 per year for all vaccines combined. (The total of reported deaths in Europe, the U.S., and the U.K. as of now is about 50,000.)

## **2) The FDA authorized the shot based on Israeli data showing safety, which was manipulated from the start.**

In terms of the data from the trial, which was unfortunately conducted upon the people of Israel without their consent (they were told that the vaccine was already FDA approved), this was a sham trial, as the government has not provided a proper reporting system to the citizens/trial subjects (until April 2021 the Health Ministry form did not even ask for contact information, or allow for a description of adverse events, and any data collected is not made public), and doctors were instructed not to admit that any negative outcomes were connected to the shots. In fact, doctors and nurses are aware that if they speak out about the adverse effects of the covid-19 shots that they are witnessing, they will lose their jobs (or worse).

While Pfizer was required by the Health Ministry's own regulations, and the FDA, to carry out constant monitoring and reporting of all adverse events in Israel during the vaccine rollout, they ignored these obligations, and the Health Ministry continues to fail to enforce them, even as the vaccine is now pushed on 12 year olds. Pfizer's violations have resulted in a complete lack of true data on the adverse effects of the vaccine in Israel, and this falsified picture was then used by other countries as a basis for their own authorizations.

Many dozens of doctors and experts in Israel are indeed speaking out, though, about the severe effects and deaths that they are seeing, which the government has not been transparent about, and I am personally in touch with four of those individuals. ## **3) Both male and female fertility are a huge concern, and the effects of the shot ARE ALREADY BEING SEEN IN THE MISCARRIAGES, STILLBIRTHS, NONSTOP STAINING AND IRREGULAR CYCLES, PREMATURE MENOPAUSE, ERECTILE DYSFUNCTION, AND MORE.**

There are a number of grave reasons for concern that have been expressed by numerous esteemed doctors and scientists, and until we follow thousands of couples who have taken the shot for a period of years to ascertain their fertility, the viability of their pregnancies, and the health of the children they bear, it is impossible to know that there are no ill effects. It is neither scientific nor responsible on the part of "experts" who want to push the shot on people of childbearing age (whose risk of death from covid is minute) to take the scientifically grounded concerns of those doctors and "erase" them with no data to back up their words.

Pregnant women were excluded from the vaccine trials, so it is really surprising that anyone could claim to "know" that the vaccine is safe for them or their babies (but sadly that is what many obstetricians are somehow doing).

In fact, the way that it works with the introduction of new medical treatments isn't "innocent until proven guilty" but "guilty until proven innocent." And, as Dr. Peter McCullough pointed out, all the regular steps in testing a new medical therapy, such as studies for genotoxicity (causing damage to DNA), teratogenicity (causing birth defects), and carcinogenicity (causing cancer), were skipped. Dr. McCullough says that the government should not be allowing pregnant women to take the vaccine, and he pointed out worrying safety reports on VAERS of pregnancy loss. "Anecdotal" evidence in the form of many, many reports from our communities has been coming in which tragically seem to corroborate the doctors' warnings about danger to fertility and pregnancy, and mandate caution for the childbearing population. Dr. McCullough – not an "anti-vaxxer" by any stretch of the imagination – states conclusively that women of childbearing age should *not take this vaccine*.

## **4) This shot is not a vaccine, AND CARRIES UNIQUE AND GRAVE RISKS.**

A traditional vaccine takes a weakened or dead bit of virus and puts it in the body to create an immune response, thus stimulating antibody production to have in store for when the person may be exposed to the live virus in the future. The Pfizer and Moderna are mRNA shots, which are gene therapy. Calling them "vaccines" makes people feel safe, but there's nothing traditional about them.

A bit of genetic code is injected into the body, instructing all one's cells to produce the corona spike protein. Previously, it was said that the injected material remains in the arm muscle where it was injected, but that has proven to be untrue. The lipid nanoparticles circulate throughout the body, and also cross the blood-brain barrier. They settle in particularly high amounts in the spleen, ovaries, testes, and bone marrow. This was not a feature of any previous vaccine. The person's cells all receive the command to start producing spike proteins, and the millions of spikes that they churn out can attach themselves to platelets and cause clotting or hemorrhaging. This was also not a feature of any previous vaccine in the history of humanity.

The spike protein has now been proven to be the dangerous part of the virus. The spike protein alone is responsible for all the complications seen in covid-19 patients. Dr. Byram Bridle admitted, “We made a big mistake. We thought the spike protein was harmless. Now we know that it’s a cytotoxin.”

The antibodies that the body produces in response to the spike proteins can indeed also have unforeseen consequences, such as attacking the cells of the body that are producing the spike proteins. This would result in autoimmune diseases, such as Guillain-Barre Syndrome (which can ultimately be fatal). Far from being an unproven theoretical concept, the risk of autoimmune diseases resulting from the covid-19 shots is actually one of the 22 possible side effects that the FDA put on their warning list back in October 2020

There are other long-term grave concerns that prominent scientists are expressing as well, such as the risks of organ failure, and that, too, has already been reported.

(I will not go into details here of the workings of the J and J shot, but I will state that the same severe adverse events are being seen, such as blood clots, sudden cardiac deaths, paralysis, severe, ongoing and disabling pain, Guillain-Barre Syndrome, and more.)

I would also like to note that researchers conducting D-dimer tests on the blood of vaccinated individuals *who seem healthy*, and looking at their blood under the microscope, are finding micro clots, which are very concerning, as these clots cause silent and irreversible blood vessel and organ damage. ## **B) This injection is INEFFECTIVE.**

**1) Cases and deaths spike in most locations upon shot or booster rollouts, and the most highly vaccinated counties in the United States as well as countries worldwide have the HIGHEST amount of cases currently.**

Vaccination began in many countries, such as Israel, at a time when the caseload was very low, and there was a huge spike and a tremendous number of deaths immediately following. These deaths were blamed on lack of vaccination and used to push more vaccination. In addition, a huge number of deaths follow the vaccine rollouts, which aren’t even associated with corona at all. <https://dreddymd.com/2021/02/18/elderly-population-suddenly-dying-off-for-unexplained-reasons-and-its-no-longer-coded-as-covid-19/>.

The tragedy of increased death and disability after vaccination has unfolded in Israel but is not known to most of the world. See the treachery of the government against its people at <https://americasfrontlinedoctors.org/frontlinenews/israel-and-pfizers-dirty-little-secret-opinion/><https://www.the-people-committee.com>, <https://www.francesoir.fr/videos-les-debriefings/israel-yativ-seligmann-juin-2021> and <https://www.nakim.org>, or call Rabbi Uri Sofer, a Dayan in Bnei Brak who can describe the death, illness, and miscarriage occurring post-vaccination in Israel. In terms of a “plausible biological explanation” for becoming ill with corona right after being vaccinated for it, experts believe that the shot weakens the immune system and thus makes people more susceptible to the virus, which their body had been fighting off successfully on its own until that point. Another possibility is that this is a short-term form of ADE. Whatever the cause, we cannot deny the reality even if we cannot yet be sure why it’s happening.

Regarding the “breakthrough cases” that are further evidence of the vaccine’s lack of efficacy, they are no longer “isolated” or miniscule. The CDC stopped publicizing the count of cases in vaccinated individuals at the end of April, unless they are hospitalized or die. See <https://www.cdc.gov/vaccines/covid-19/health-departments/breakthrough-cases.html>

At last publication on April 30, the case tally in the U.S. was 10,262 fully vaccinated people who tested positive for corona (see link above). **They aren’t telling us the current numbers of people who only test positive or became ill, for obvious reasons. The numbers are in the hundreds of thousands, as the shots aren’t working.**

Stories surfacing show that the cases in vaccinated people are skyrocketing. Consider a post from a very pro-vax doctor in Los Angeles, Dr. Sam Fink, who reports speaking with seven new covid patients, four of whom were vaccinated...with two of those being hospitalized. He also mentioned being told of a dinner party that resulted in 8 vaccinated people getting covid, 2 of whom are hospitalized...and they're only in their 40's. While he is trying to make the case for continued safety measures and isn't saying not to vaccinate, one cannot help but wonder from his words what exactly the vaccine IS accomplishing?

Dr. Peter McCullough said that it is clear that vaccinated people **are transmitting the virus**, and that the **vaccines actually do not seem to be working at all against the Delta variant, and therefore are becoming obsolete at this point in time**. In fact, PHE (Public Health England) reports show that not only is the vaccine **not** helpful in reducing death, it actually **increases** the risk of death in vaccinated individuals who contract covid. Hospitalized covid patients with the Delta variant were found to be **six times more likely to die if they were fully vaccinated** than if they were unvaccinated (people who had received 1 dose fell out in the middle of this range.) This data corroborates the scientists' warnings about ADE (namely, that vaccinating for certain viruses, coronavirus among them, causes the body to react in a worse way than it otherwise would, when faced with the infection).

**Current data from England, where they are more transparent, shows that 82% of covid 19 deaths in the past month were among those who were fully vaccinated.**

**Dr. Peter McCullough stated clearly in testimony to the Rabbis of the Beis Din where he testified in Brooklyn on October 26, 2021, that no matter an individual's age or prior risk factors, they are better off taking their chances with the virus itself – even if they do not have access to proper early treatments – than with the covid injection.**

## **2) Continuous booster shots will be required forever.**

While most people believed that they would be immune for a very long time after vaccination, all the recent evidence that has come to light proves that this simply is not the case. While natural immunity is extremely long lasting, and likely to be lifelong, whatever immunity the vaccine may have provided is proving to be short-lived and not adaptive to different strains. The solution, rather than boosters for each variant that will again expose the recipients to the risks of death and disability from the shots, is **safe and effective prophylaxis and early treatment**, which has been the answer all along.

## **C) THIS SHOT IS UNNECESSARY. We HAVE effective treatments for corona.**

See [macabim.org](http://macabim.org), [fccc.net](http://fccc.net), [budesonideworks.com](http://budesonideworks.com), <https://c19protocols.com> and <https://covid19criticalcare.com/>, or [c19studies.com](http://c19studies.com), for various extremely effective covid-19 prophylaxis and treatment options and the clinical trials to back them up. These treatments work against **all** variants and are proven to reduce hospitalization and death. Yes, they **work better than the vaccine**, and yes, they are used to **prevent and to treat covid**.

*Using these preventative and early treatment medications appropriately, rather than mandating lockdowns and distancing, would bring us to herd immunity.*

Anyone in a medium risk or high risk category should ideally be on a preventative regimen, or at the very least, have the treatments at home to begin at the first sign of symptoms. This includes vaccinated individuals because it is becoming increasingly clear that the vaccine is *not offering adequate protection*. In fact, Dr. Zev Zelenko stated that it is *especially critical for vaccinated individuals in particular to be on a prophylactic regimen against corona* because their chance of becoming much sicker with it, G-d forbid, is greater.

If there are effective treatments for corona, **AS THERE ARE**, *no vaccine is needed*.

Tens of thousands of corona patients have been saved with them. In fact, they are so effective that the vaccines would never have gotten Emergency Use Authorization if the treatments would have been acknowledged by the FDA. It is absolutely scandalous that the FDA pretended, and continues to pretend, that there is no cure for corona. The government, mainstream news media, social media, and pharmaceutical companies are working together in a coordinated effort to suppress the knowledge and availability of these safe, effective treatments and preventions, and to vilify them.

The studies are there, and the proof is overwhelming. Educated doctors **use these treatments and save thousands of lives**. Used *correctly*, the proper early treatments can save *almost everyone*. As Dr. Zev Zelenko so aptly put it, there are only two risk factors for corona: the doctor you choose and the government you live under. **With the right treatment, virtually nobody had to die in this pandemic, no matter how old or what comorbidities they had**. If you doubt this, ask Dr. Zev Zelenko, Dr.

Peter McCullough, Dr. Richard Bartlett, Dr. Ryan Cole, Dr. Richard Urso, Dr. Paul Marik, and other heroes what their secret is to saving so many thousands of lives. It's actually **not** a secret – they do their best to share it with the world. It's the simple protocols of HCQ, Ivermectin, Vitamin D, Vitamin C, zinc, Budesonide, and anti-inflammatories, anticoagulants, and antibiotics as needed. There are also natural supplements that help tremendously. These **aren't "new."** **All these treatments have been known for a year or more, but they are not being used by most doctors and hospitals, and that is why people are still dying.**

**The government is spending billions to promote the vaccine and "save lives," but if they truly desired to save lives, the first and easiest thing that they could have done would have been to encourage Vitamin D supplementation. Studies show that people with an excellent Vitamin D blood level (a level over 50) simply do not end up in the ICU, or die of corona. *Why is this fact not all over the news?***

In order to have an effective dialogue about this topic, it is *necessary* to acknowledge the open and proven fact of the censorship of information about effective corona treatments (and of the dangers of the vaccine). You can look it up.

**WHERE DO WE GO FROM HERE? Now, NYC has mandated the covid injection for ALL teachers, and all private sector employees! Certainly, children will be mandated next, and children's mandates have already begun! WE MUST GROUP TOGETHER TO RESIST WITH ALL OUR MIGHT!**

Obstetricians, Chevrah Kadishas, and others all are now giving the same horrifying testimony about the current situation of dozens of stillbirths and miscarriages. These are not only in women who got the shot, but also those whose husbands or others around them were vaccinated. People are collapsing or not waking up. Others suddenly have brain bleeds, clots, or heart attacks. We cannot allow this substance to be put into our children or into their Rebbeim and teachers!

**My people, please wake up!**

**HOW IS IT POSSIBLE that any parent or principal would want this poison put into someone they care about?**

**How could it conceivably be permitted in halacha?**

Indeed it is completely forbidden, and akin to murder. As I mentioned above, on October 26, the same day as the disastrous FDA meeting, a Beis Din met in New York and heard EIGHT HOURS of testimony from 10 expert doctors and scientists from around the world, from covid vaccine injury victims, and from a lawyer who testified about how the government is hiding the true data. The Beis Din came out with a ruling that it's completely forbidden to give children and people of childbearing age the covid shot, and anyone who has the power must protest it with all their strength. They also gave strong warnings about the danger of the shot for all age groups, with special mention of the miscarriages that the injection is causing, *Rachmana litzlan*. **Remember that Bill Gates, who FUNDED the development of the covid injections, has specifically and repeatedly stated his desire to reduce world population growth through vaccines. Shouldn't we take his word for it?**

As Jews, who have suffered through so much, we should know better. We should be suspicious. *Bechol dor vador omdim aleinu lechaloseinu...* why have we been so trusting of our government's actions? The time to trust is over. They are covering over the true death rate, they are forcing people with natural immunity to get the shot or lose their jobs, and most telling of all, they have murdered hundreds of thousands by suppressing the effective medications that cure covid.

It is clear that the GOVERNMENT has an agenda. They do NOT CARE ABOUT OUR LIVES. It is time for us to stick together and say NO! Even if we will lose ALL our government funding, it doesn't matter. All the millions given to our health clinics to push the shot, and all the money given to schools to get teachers to vaccinate, is dirty money, stained with the blood of our people. It's time to flush that down the drain, and stand up as one and resist. Our children and their teachers are NOT FOR SALE! If all the schools will lose their funding, so be it. **It really doesn't matter if someone you trust is telling you that you can or should get this shot or give it to your child. **Don't be fooled by ads sponsored by government money urging this deadly, ineffective shot, and likening it to the polio vaccine. It's a world of difference. This virus has effective medication for treatment and prevention, and this shot isn't even a vaccine. It's a computer-created genetic code that programs your body to create trillions of toxic spike proteins. The same murderous evildoers, such as Fauci, who created the virus in the lab in Wuhan that unleashed so much misery upon the world, now seek tens of billions in profits by offering you their deadly cure. It's like Mengele, y"sh, offering you an injection, and he has zero liability. Who would be so foolish as to accept it?**

**There is a ridiculous notion about the vaccines being the way out from the inconvenience of quarantine. The truth is that the only way that the craziness of quarantine will end is not by vaccination, which in any case has proven to be ineffective, but when we start taking control of our own health, with G-d's help, and treat covid symptoms early at home with treatments that work, as we do for any other treatable illness. We need to stop allowing the government to dictate our lives and lock us up at will. There is no need to live in fear, or to test or quarantine asymptomatic people. There is no proof that testing and quarantining asymptomatic individuals helps, and we have never done it in the past. We don't need to do it in this case, either.**

**Please remember, *many* drugs and treatments in the past have been widely accepted as safe, factual, and proven, only to be disproven and found dangerous afterwards.**

**This certainly will be the case with the current covid-19 vaccines. a) the typical safety trials have been skipped, b) not enough time has passed to know long-term consequences, which we *always* want to be sure of before injecting a substance into such a large portion of the population, and c) *the danger signals are very strongly present and are being ignored by the responsible governmental bodies, who ought to be investigating them. We are as far as we can possibly be from being assured of the safety of these injections in the short term or the long term.***

**One more caution: Do not fall into the testing trap! The school covid tests are a stepping stone to covid vaccination. The tests are an integral part of the government's evil plan. Schools and parents, just say NO!**

**Postscript: Here are some serious questions to ask and seek the answers to. (Many of the answers are available at [macabim.org](http://macabim.org).)**

- 1) What is the safety data on the vaccine? Request the trial data. Why were hundreds of people removed from the study mid-trial with no explanation? Is it possible that they removed individuals who suffered severe adverse events after Dose 1, whom they do not wish to count (as they did with 12 year old Maddie DeGaray, who became paralyzed but is **not** reported in the trial data?) Why is the raw trial data **not** being made available? **Who supervised the trial other than the drug companies?**
- 2) Request the Pfizer 6 month studies. Do they show a lower or higher rate of death when comparing vaccinated individuals with unvaccinated?
- 3) If the studies of Pfizer, Moderna, and J and J are not completed till about 2023, according to their websites, are people that are taking the vaccine part of those trials?
- 4) If the CDC says that they reviewed the reported deaths and side effects using "limited available data," how can we assume that the data that wasn't available means there is no connection to the vaccine on those accounts? Shouldn't it be guilty till proven otherwise? You can't say it's connected or not connected until it's fully investigated.
- 5) If the CDC claimed that the PCR is not an effective tool for detecting COVID 19 and won't be used as of December, why are we using something ineffective till then, and are the results valid?
- 6) If natural immunity is as effective or more effective than vaccinated immunity, why are the naturally immune being placed in the category of unvaccinated?
- 7) What are the data on the side effects of on those that are recovered and vaccinated as opposed to vaccinated without prior infection?
- 8) If the spike protein has been found to be the cause of many of the symptoms of corona, what are the risks associated with having the body create it even for short periods of time?

- 9) Since the lipid nanoparticle was found to travel all around the body and not stay in the deltoid, what is the data on the extent of this in participants and how long it lasts?
- 10) Regular RNA that is found naturally in the body gets degraded quickly. However, the mRNA in the vaccine is wrapped in a lipid nanoparticle (fat) to make it not disintegrate quickly. What data is available in regard to the amount of time for mRNA wrapped in a lipid nanoparticle to dissolve?
- 11) Could the vaccine cause the virus to mutate into something more infectious, thereby keeping corona around forever?
- 12) Can vaccinated people still transmit the virus? Dr. Fauci is adamant that the vaccine does NOT stop transmission! Then why is it being used as the condition for rejoining elderly people, restaurants, and travel?
- 13) What is the safety data of children or adults wearing a mask and for how long? Where are the studies showing that masks protect their wearers from viral infection? Aside from the overwhelming evidence showing that they do NOT protect, does their likelihood of causing grave harm, such as asthma, oral problems which can lead to heart disease, and increased susceptibility to lung infection due to decreased oxygen, plus the emotional and psychological effects of wearing a mask - for kids and adults - outweigh the risks of getting sick? Look at the studies.
- 14) What is the number of deaths plus serious side effects from the vaccine reported in children, compared to deaths from corona in healthy children? See German study above. See also Israeli data. Remember that US data from the CDC has been corrupted by counting deaths of children who are sick with *other illnesses* and happen to test positive (with the PCR test that even the NYT admits gives up to a 95% false positive rate.)
- 15) How many reported deaths will it take to put a pause on the vaccine or take it off the market? Compare the current number of deaths with the death rate for other drugs previously taken off the market.
- 16) Checking vaccine data in both England and Israel, results are that about 40 x more elderly died after vaccine than in same time period before the vaccine. Why are they continuing to force this vaccine on the elderly who can't protect themselves? There are also eye-witness accounts of elderly in nursing homes losing their ability to walk, talk, and think coherently after receiving the vaccine, on an alarming scale. The CNAs are horrified at what is happening to their patients. In some countries, they stopped this barbaric attack on the elderly when they saw the effects. Why isn't the FDA or CDC publicizing this and warning that the vaccine is not safe for the elderly, the very people they are proclaiming to protect. See firsthand reports from the nursing homes.
- 17) If the vaccine only proposes to modify symptoms, and not prevent infection, then why are young people being asked or coerced to vaccinate? As a rule, most young people are asymptomatic or have mild symptoms if they get corona. However, the vaccine puts them at risk for heart attack, infertility, neurological disorders, allergic reactions, MIS, etc. Those who have suffered these casualties, needlessly suffered or died because they didn't need it in the first place.
- 18) If the vaccine immunity wanes after 2-6 months and natural immunity in many has lasted over a year, why are the immune being pushed to vaccinate?
- 19) If someone does not have an anaphylactic reaction to the vaccine, does not get facial paralysis or neurological damage like unstoppable shaking, does not get irreversible heart damage or MSI or hemorrhaging, they may "only" have to worry about the possibility of ADE when coming in contact with the live virus, other long-term effects, or possible infertility. However, the proposed benefit of possibly getting through corona with light or no symptoms is only supposed to last a few months and then what? Expose themselves to a new vaccine every few months, with whatever the latest "additive" has been put in by Dr. Fauci?
- 20) Maddie DeGaray, a child who was in the Pfizer trial, is paralyzed and they are not admitting that, so how can we trust their other safety data?
- 21) May a healthy child be injected with a pharmaceutical product – which always carries risks and unknowns – for the presumptive purpose of decreasing the chances of others becoming sick?
- 22) Under what circumstances, if any, is it permissible for healthy Jews to submit to a medical experiment?
- 23) Is there any halachic precedent to allow doctors virtually unlimited control over all of Klal Yisrael, indefinitely?
- 24) On what basis can all of Klal Yisrael be instructed to surrender the power to decide when, if, and under what circumstances they may daven, learn Torah, educate their children, and otherwise live a normative Jewish life to any outside group? Even the

Sanhedrin did not exercise such absolute control over the daily life of Klal Yisrael; why is a group of people who are overwhelmingly not Jewish, and even heretics, entitled to greater power over Jewish life than the Sanhedrin?

25) Even in cases where the majority of doctors are followed, shall the opinions of doctors who have not independently studied and demonstrated proficiency in the pertinent science be counted?

26) Similarly, must we count the “majority” opinions of doctors who have conflicts of interest, or risk serious repercussions if they express a view contrary to the establishment?

27) On what halachic basis are we obligated to assume that doctors, rabbis, or anyone else with a serious negi'us (vested interest) will not be influenced by this, especially in matters where we are assuming risks to our health and they bear no liability for anything that happens to us?

28) On what halachic basis must we assume that pharmaceutical companies with an unbroken history of satanic greed and disregard for human life shall be trusted, especially when they have nothing to fear from the law and they have tremendous leverage over the agencies that are supposed to oversee them?

29) On what halachic basis must we assume that government agencies, politicians, health officials, and other influencers of public opinion can be trusted when they have lied, made gross mistakes, engaged in deceit and manipulation, and receive funding from the pharmaceutical companies whose products and positions they endorse? At what point according to halacha does a doctor with a valid medical opinion become compromised?

30) If a Rabbi has a position with an agency that has negi'us, or will otherwise suffer repercussions if he expresses a view against the “majority,” on what basis can we assume that his support of their position is not influenced by this? On what basis can we be so sure that this negi'us has no influence over his support of their position that we may bank our physical and spiritual lives on it?

31) In the entire course of Jewish history, during which our nation endured many plagues, has there ever been a response so widespread, intrusive, authoritarian, and unlimited both in scope and duration? Why does this situation justify such a radical departure from everything in Torah and tradition? On what basis are so many rabbis urging this radical departure with total conviction and severe condemnations for those who don't fall completely into line?

32) If a Rabbi instructs a healthy person to submit to a medical experiment (even if – especially if – it is referred to in other terms), and that person is harmed in any way, is the rabbi liable in human courts or the Heavenly court?

## Official translation of the Halachic delineation

rendered and signed on the 22<sup>nd</sup> of Marcheshvan (after hearing eight hours of testimony from experts and other witnesses), with partial additional elaboration:

We the undersigned convened together to render judgement regarding the new "Covid 19 vaccine" (which we shall henceforth refer to as "injection", "vaccine", or "mRNA", although our intention is to include the "Adenoviral vector DNA" vaccine as well), and we heard testimonies from experts whose expertise is in this field. We also heard from doctors who invented and manufactured the mRNA, who testified as to its function (most doctors in medical practice are not experts in these matters at all, and from our experience and as is well-known, they merely relate the information provided to them by the NIH, CDC, etc.). They illustrated to us the profound danger and harm inherent in this new technology. They showed us how the governmental agencies and the pharmaceutical companies deny this fact, and how they conceal the data, making it so difficult for the public to realize the severe adverse reactions and mortalities that have befallen so many people who received the injection. We were also made privy to how they withhold the said information through various means, preventing the injuries and deaths from being publicized by the media or on the internet, as known.

We also heard testimonies from our fellow Jews who suffered injuries, and even worse Heaven forbid, and also how this injection is harmful to procreation and fertility. And most importantly – we heard how there are tested and simple medications that have been successful in treating this disease, yet the governmental agencies have denied this, and even outlawed the said medications, doing everything they can to promote fear, not health – despite the fact that they themselves were aware that these medications work.

And now they have approved the mRNA for children as well – for whom it is universally known and is accepted fact that the disease presents no risk of danger – and their intention is to mandate the injection for children as a requisite for attending yeshivas and religious girls' schools, Heaven forbid.

The evidence presented, which includes reports of injuries actually due to the vaccine, or reasonably suspected to be due to the vaccine, as well as scientific knowledge suggesting the vaccine will cause, or may reasonably be suspected to cause harm (until proven to the contrary by adequate testing), provides a level of concern that exceeds Halachic standards.

**Therefore, we hereby express our rabbinic decision, as per the teachings of our holy Torah – a definitive Halachic ruling:**

- 1) It is absolutely forbidden to administer or even to promote this injection to children, adolescents, young men or women; even if it means that they will not be permitted by the government to attend yeshiva or seminary or to study abroad, etc. It is an explicit obligation to protest against this mandate, and anyone who can prevent the injection from being forced upon our youth must do so, forthrightly and emphatically.**

The above admonition is in addition to the otherwise Halachically reprehensible nature of the injection:

- 1) due to its Halachically problematic ingredients; 2) due to the fact that no one is liable for the possible damages caused by the injection, unlike most other contemporary medical treatments and therapies; and 3) because administering the injection to one's child assists the government in forcing other children to take it as well.
- 2) Much harm appears to be caused to pregnant women as a result of the injection (possibly due to the antibodies that the body develops against the protein called Syncytin-1, or from the SM102, or from the micro blood clots caused by the injection. The common denominator here is that it is harmful for a pregnant woman, and that it may be considered a violation of the prohibition of sterilization or preventing fertility). As such, it is forbidden for them to take this injection. Included in this are all healthy adults who are of child-bearing age – they too should stay away from the said injection. (There are many reports of women who do not stop bleeding for many months as a result of taking the injection, making it impossible for them to achieve ritual purity, Heaven forbid. And for men, there are many reports of the injection leading to deficiencies in potency, Heaven forbid).**

Significant follow-up acknowledgement:

We have been advised that the product label for the Pfizer injection states "Available data on COMIRNATY administered to pregnant women are insufficient to inform vaccine-associated risks in pregnancy." We have also been advised that the CDC is conducting studies where there is an "urgent need" to study the effect of the vaccines in pregnancy. We have been further advised that the product label for the Pfizer vaccine states that it has "not been evaluated for the potential to cause carcinogenicity, genotoxicity, or impairment of male fertility." We consider that the risks inherent in these statements are Halachically unacceptable.

- 3) **For older adults and the elderly, further clarification is needed (but as mentioned above, there are efforts to obscure the data, and it is presently difficult to attain accurate clarification). However, practically we have seen breakthrough cases, indicating that there is no substantial difference between those who received the mRNA and those who did not. The number of Covid patients are about the same, comparatively, in both demographics.**

It has also come to our attention, thanks to the testimony of an attorney who closely monitors the promulgation of misinformation, who showed us how to interpret the true reality and frequency of injuries and mortalities from the data being shared. It should be known that much of the data the government agencies report is deceitful. For example, a Covid death that occurs in a person after receiving the injection, if it happened within fourteen days of receiving the injection, is listed as an "unvaccinated" death. For the sake of brevity, we will not go into further particulars; but let it suffice to say that there are more examples of this gross misrepresentation. In order to ascertain the truth and arrive at accurate findings, we really must examine the matter further – to the best of our ability.

**Alternatively, there are many injuries and risks involved which can reasonably be suspected as having been caused by the injection for adults and senior citizens as well, for we have witnessed many elders who passed away shortly after receiving the mRNA.**


**Therefore – it is best to err on the side of caution and abstain from taking the injection, rather than endangering one's life by performing an action that can engender immediate and direct harm. Especially since there are other medical treatments that work, as mentioned, and that are not harmful.**

**(It is also proper to emphasize the importance of using the treatments very early, which has been shown to enhance their effectiveness. In addition, we cannot understate the importance of becoming more educated about the true facts – for example, by watching the testimonies – and in this way, assuaging the fear which has overtaken so many).**

- 4) **We have heard testimonies from individuals and from experts in the medical field, suggesting that it may be dangerous for pregnant women to be around people who have had the injection. This can be due to a phenomenon called "shedding," as it pertains to some types of vaccinations and gene therapies as discussed in the FDA's guidance on shedding from gene therapies. It is unclear whether it applies to the gene product only (the spike protein) or also to the genetic message (the mRNA or the adenoviral vector). It is unclear how long the shedding might be taking place – i.e. how long a recipient of the injection can affect a pregnant woman by being in her proximity. Hence, it is best to err on the side of caution – a minimum recommendation of distancing oneself from a pregnant woman for at least two weeks after receiving the injection is strongly suggested (although some have suggested that the effect may last up to ten months, or may even be indefinite).**
- 5) **The prohibition (Leviticus 19:14) of putting a stumbling block in front of a blind person – i.e. assisting or enabling a person to violate a transgression – includes verbal encouragement, offering monetary incentives or other bribes, verbal pressure or actual threats, to coerce employees, etc., to receive the mRNA.**





Thank you for reaching out to me.

I write to you to confirm my concerns regarding Covid and the vaccinations. I voice these concerns here.
